

Safeguarding Flow Chart for Parishes in the Diocese of Lincoln

If you suspect someone is being abused or is at risk of being harmed
Or If someone tells you about anyone harming another person (whoever they are)

If a child or an adult tells you about being abused by someone else this is called a disclosure. It is important you respond well

Make a written record of the facts as you know them. Write down what you observe and what is told to you as soon as is practicable. Do NOT trust your memory.

Report the matter immediately to your Vicar/Rector/Priest in charge (unless they are the source of concern) If they are not available, contact the PCC Safeguarding Officer

Seek advice from The Diocesan Safeguarding Team or from the Archdeacon if you can't reach the Safeguarding Team.

DO NOT talk to others in your parish except the person who needs to know to support you. Do not start to, investigate or alert any possible perpetrator.

Keep calm, and allow them to speak without interruption, accepting what they said. Use active listening skills and try not to appear shocked. Do acknowledge their courage in telling you and do reassure them they are doing the right thing by speaking out.

DO NOT ask any leading questions, though you may ask for clarification; How? When? Where? Open questions are acceptable. "Tell me" "explain" "describe"
 TED will help you remember

If the individual is injured, seek medical help.
 If the individual is in immediate danger, report it to the Police (999) or the Local Authority teams listed below. Do not delay!

Let the individual know that you will have to pass this information on. Try to alleviate feelings of guilt and isolation, while passing no judgement.

Try to ensure that you agree a plan with the person that is disclosing to you that enables them to feel safe and so they know what you are going to do next

Make a detailed written record of what was said, and what was done, including anything that you said and any advice or direction you are given by those you report the incident to.

Immediately inform the Diocesan Safeguarding Team who will advise you what to do next.

If the Safeguarding Team are not available contact the Archdeacon If it is urgent remember you can talk to the Local Authority or Police without having spoken to the Diocese first. The Diocese are there to support you but do not delay urgent referrals

DO NOT talk to others in your parish except the person who needs to know to support you Do not start to, investigate or alert any possible perpetrator
